THE RONALD MCDONALD HOUSES PROVIDE A "HOME" ALLOWING FAMILIES TO EAT, SLEEP AND FIND THE EMOTIONAL SUPPORT THEY NEED TO CENTER THEIR ENERGY ON THEIR SICK CHILD. FAMILIES ARE PROVIDED WITH CLEAN, PRIVATE AND PROXIMATE ACCOMODATIONS ALLOWING THEM TO FOCUS ON THEIR CHILD'S CARE. WE SUGGEST A \$10 PER NIGHT CONTRIBUTION FROM FAMILIES; HOWEVER, NO FAMILIY IS EVER TURNED AWAY IF THEY ARE UNABLE TO PROVIDE THAT CONTRIBUTION.
